**Important Guidelines for Australia Tourist Visa Application:**

**1. Application Timeline:**

Visa applications must be submitted **minimum 5-6 (five to six) weeks prior to the intended date of travel.**

**2. Accuracy of Information:**

Providing **false or misleading information** on the visa application form or during the visa interview may result in **permanent ineligibility to enter the Australia.**

**3. Visa Decision Responsibility:**

**Visa issuance is solely at the discretion of the Australian Embassy.** SHREE SWAMINARAYAN TOURISM is **not responsible** for any visa refusal, rejection, or delay in processing.

**4. Processing Time:**

The **Australian ETA visa processing time** is approximately **2-5 working days.**

Updates will be shared as soon as we receive any communication from **Australian Immigration.** Please note that processing time varies depending on the **individual application.**

**5. Visa Type and Delivery:**

The **Australian visa** is an **E-Visa.** The decision will be received via **email** and shared with you promptly once received by SST.
