Important Guidelines for New Zealand Tourist Visa Application:

- 1. Application Timeline:**
Visa applications must be submitted **minimum 5-6 (five to six) weeks prior to the intended date of travel.**

Providing **false or misleading information** on the visa application form or during the visa interview may result in **permanent ineligibility to enter the New Zealand.**
- 3. Visa Decision Responsibility:**
Visa issuance is solely at the discretion of the New Zealand Embassy. SHREE SWAMINARAYAN TOURISM is **not responsible** for any visa refusal, rejection, or delay in processing.
- 4. Processing Time:**
The New Zealand **ETA visa processing time** is approximately **2-5 working days.** Updates will be shared as soon as we receive any communication from New Zealand Immigration. Please note that processing time varies depending on the **individual application.**
