Important Information (Please Read Carefully)

- **Tourist Visa Purpose:** A Singapore tourist visa permits entry only for tourism, leisure, and short social visits or family visit.
- **General Checklist Requirement:** This is a standard document checklist. Passengers must provide all required documents.
- **Visa Form Preparation:** Visa application forms (Form 14A) will be filled by passengers.
- **Processing Time:** Your visa application will be processed in 3 to 5 working days (excluding the day of submission, Weekends and Holidays). Some applications may take longer to process. Each visa application will be considered on its own merits.
- **E-Visa Issuance:** The Singapore visa is issued as an **e-visa**, and “SST” will send the approved visa to passengers immediately once received from the Consulate.
- **Visa Fee Requirement:** Visa fees must be paid in advance prior to filing the application. An invoice can be provided in your personal or company name as required.
- **Consulate’s Decision:** Visa approval, refusal, or delay is solely at the discretion of the Consulate of Singapore. “Shree Swaminarayan Tourism” will not be responsible for any rejection, delay, or additional requirements imposed by the Consulate.
- **Fee Changes:** Visa fees, requirements, and processing timelines are subject to change without prior notice based on Consulate guidelines.

6. Bank Statement: Last 6 months, signed & stamped, showing sufficient funds.

8. Hotel Booking: Confirmed hotel reservations.		
9. For Family visit: V39A Form, Invite passport copy, visa copy, Residential proof		
10. Employment/Business Proof: Leave letter & salary slip if employed; company registration if self-employed; student ID if studying.		
11. Marriage Certificate: Required if spouse traveling together (If applicable) For honeymoon purpose: Wedding invitation required		
12. Minor Documents: Birth certificate, NOC from parents, passport copies is child is below 18.		
13. NOC from parents with proof of signature for minor child traveling without parents on 50/100 RS. stamp paper		
14. Document Submission: All documents must be submitted in hard copy.
