- Ticket confirmation in PDF

- You should have sufficient means of living to support your stay in Thailand (minimum 10,000 THB/person, 20,000 Baht/family).
- Departure and Return Airline tickets

- Full trip of accommodation details
- **Documents for visiting relatives:-**
- Invitation letter from invitee side.
- Passport copy first& last page also visa copy of invitee on which visa they are staying in Singapore.
