PLEASE READ THE FOLLOWING INFORMATION THOROUGHLY AND MAKE SURE THAT YOU FULFILL ALL THE REQUIREMENTS ESTABLISHED BY LAW,

- A tourist visa is a type of visa that allows individuals to enter a country for the purpose of tourism and leisure activities. In the context of Thailand, a tourist visa allows foreign nationals to visit Thailand for a temporary period for tourism. It does not permit the holder to work or engage in any business activities.

- The required document list is given below. Please note that this is a general document list, so please provide documents that are appropriate as per your profile.
- The visa question form is filled out by passengers individually with a sign. This form helps us fill out visa application.
- The visa form will be filled out by SST only after the passengers submit all the documents and do the payment and give the go-ahead to process.
- Visa fee details are mentioned in the below section, which you have to pay to SST.
- A cover letter that explains the purpose of the visit has to be given by the passenger on their business letterhead, if any, or can be given on a formal letter with the main applicant's signature and designation stamp. A letter format is attached to this file for your reference.
- Thailand visa processing takes 9 to 12 working days. Please note that the processing time will depend on your application and the Embassy.
- The Thailand visa is a Sticker-visa, we will submit to VFS and once the decision will be taken by the consulate they will send back the Passport to our Head Office. We will notify you once it is received by SST.
- Visa payment is required in advance before applying for your visa file, and we will provide you with an invoice copy as per your requirement. If you want to use your own name or company name.
- Visa issuance is the sole responsibility of the Embassy. Flamingo is not responsible for any rejection, refusal, or delay in a visa.
- For the Thailand visa process, all the necessary documents should be photocopies, except those that are asked to be original.
 - **All documents will be submitted at VFS.**

FOR THAILAND VISA, PLEASE READ BELOW PROCESS CAREFULLY.

- Passengers have to pay VFS fees at the SST, which include VFS fees, Visa fees, service charges, and courier charges (approximately \$5500 per passport).
- We will prepare file with visa forms, photographs, cover letters, courier forms, tour vouchers, tickets, financial documents, etc.
- Once they go through the documents, they will ask you to pay fees. Once payment is done, we will give you a receipt and proceed.
